**Students seeking admission under the BPL category must fulfil the following conditions and produce the required supporting documents:**

1. To avail free admission, the class attendance should not be less than 70 % in the preceding academic year.
2. The annual parental income from all sources must be less than 4.00 lakh per annum to be eligible under the scheme.
3. If either parent (mother or father) is employed in the State Government, Central Government, Semi-Government, or any State/Central Government undertaking, the student shall not be eligible under the scheme.
4. The student must produce either

\*Ration Card Issued by competent authority, or

\*Income Certificate of the parent(s) issued by the Circle Officer only, as prescribed

under the Government of Assam, Higher Education Department Notification.

### **Important Instructions:**

The students having arrears/backlogs in the previous academic year(s) shall be eligible to avail the benefit of the Free Waiver Scheme, subject to the condition that only 50% (fifty percent) of the applicable fees shall be waived in respect of such students.

\*BPL students must submit the required supporting documents for verification.

\*Students with back papers must pay 50% the applicable fee as mentioned in the fee structure above. Students are advised to retain the payment receipt/transaction details for future reference.
