



MEMORANDUM OF UNDERSTANDING(MoU)

COMPUTER APPLICATIONS DEPARTEMT, MORIGAON COLLEGE,
MORIGAON, ASSAM
AND
BRILLIANT IT ACADEMY, JAGIROAD, MORIGAON, ASSAM

This MEMORANDUM OF UNDERSTANDING ("MOU") is made by and between the Computer Applications Department, Morigaon college, Morigaon, Assam (hereinafter "CA-MC"), and Brilliant IT Academy, jagiroad, Morigaon, Assam (hereinafter "BITA"). Both CA-MC and BITA shall also be collectively referred to as the "Parties" or the "Institutions."

RECITALS

WHEREAS, the department of computer applications, Morigaon college and the brilliant IT academy, both have computer science / applications related programs and affiliated professional computer courses that are involved professional skill development education for students; and

WHEREAS, "the department of computer applications, Morigaon college" and the "Brilliant IT Academy" desire to establish certain exchange programs beneficial to the respective educational Institutions and to promote the development of joint studies, quality development of students, resource sharing, computer Laboratory sharing and training activities, and other educational exchanges of mutual interest.

NOW THEREFORE, in contemplation of the mutually beneficial relationships to be established, and in consideration of the mutual promises and covenants contained herein, the sufficiency of which is hereby agreed to and accepted, the Parties agree as follows:

TERMS

1. Purpose of the MOU:

1.1 The primary objective of this MOU is to create a means for cooperative efforts between Computer Applications Department, Morigaon College (CA-MC) and Brilliant IT Academy (BITA) to affect the academic and interchange of faculty and students of department of computer applications, MC and jointly participating academic departmental activities, sharing resources, sharing laboratories, sharing departmental libraries between the two Institutions.

1.2 The Parties agree that this MOU will provide the foundation and framework for particular projects (BCA project work), developed by academic students from the two Institutions.

1.3 "Home Institution" refers to the Institution sending its student(s), or faculty member(s) to the other Institution for the purposes of study, teaching-learning.

1.4 "Receiving Institution" refers to the Institution hosting the visiting student(s) or faculty member(s) from the other Institution for the purposes of study, teaching-learning.

2. Agreements of MoU:

The Computer Applications Department, Morigaon college (CA-MC) and Brilliant IT academy (BITA) wishing to enhance cooperation and friendship between the two institutions, agree upon the following provisions for academic and educational exchanges:

1. The two institutions agree to encourage academic and educational cooperation in fields of mutual interest including:
 - a. Exchange of faculty and/or staff;
 - b. Exchange of undergraduate (BCA) students;
 - c. Joint bilateral academic meetings;
 - d. Joint skill enhancement programs and participation of concern departmental activities.
 - e. Exchange of academic materials and other related resources.
2. Each short-term staff visit will require the prior approval of the receiving institution that provides reasonable living accommodations and subsistence for the visitor for the duration of the visit.
3. Qualified undergraduate students nominated by one institute will be accepted as undergraduate students by the other institute for advanced study, provided the receiving institute is satisfied that the students are qualified to pursue the proposed program and the relevant department is able to offer the necessary facilities and supervision.
4. All travel and living expenses will be the responsibility of the sending institute or of the students personally. The receiving institute reserves the right to charge the normal level of tuition fee unless the two institutions agree that the student enrolment is to be included under a balancing exchange arrangement for such student exchanges.
5. Both institutions agree to expeditiously process all requests submitted under this Agreement and to make every effort to negotiate for terms that are mutually satisfied in all cases.
6. Both institutions will encourage joint collaborations and will try jointly to share resources support for collaborative development of students (BCA students) as well as Library resources.
7. The BITA have provision to take admission for BCA courses under the MC for providing quality education to BCA students as well as will share computer laboratory which satisfied by partner institution.
8. The BITA will train the students of the First Party (CA-MC) on the emerging technologies in order to bridge the gap in skill and make them ready for industry.
9. The Second Party (BITA) will extend the necessary support to deliver guest lecturers to the students of the First Party (CA-MC) on the technology trends and in house requirements.
10. The Second Party (BITA) will actively engage to help the delivery of the training and placement of students of the First Party (CA-MC) into internships/jobs.

This Agreement constitutes the entire Agreement between the parties. There are no understandings, agreements, or representations-oral or written-not specified herein regarding this Agreement. The Agreement will become effective immediately on the date of signature by the designated representatives of both institutions and will remain in force for a period of six years from the date of the last signature. The Agreement may be amended or extended by mutual written consent of the two parties. The Computer Applications Department, Morigaon college and Brilliant IT Academy, by the signatures of their authorized representatives below, acknowledge having read and understood the Agreement and agree to be bound by its terms and condition
