Memorandum of Understanding (MOU) Between

Morigaon College and

Morigaon Girls H.S. School

Morigaon College and Morigaon Girls H.S. School, wishing to enhance cooperation and friendship between the two educational institutions, agree upon the following provisions for academic and educational exchanges:

- 1. The two institutions agree to encourage academic and educational cooperation in the fields of mutual interest including:
 - a. Taking classes by college teachers in school at regular interval
 - b. Nurturing school students for higher education
 - c. Providing career guidance opportunities to the school students
 - c. Providing access to the college laboratories for school students
 - d. Extending helping hand to school students in preparing projects
 - c. Joint bilateral academic meetings;
 - d. Joint research cooperation and community development program
 - e. Exchange of academic materials through opening up of college library for school students
- 2. The college will inform in advance to the school on matters of taking classes/ academic activities. The college has to send a list of teachers along with timing to the school. Travel expenses will be the responsibility of the college.
- 3. Each short-term staff visit will require the prior approval of the receiving institution that provides reasonable living accommodations and subsistence for the visitor for the duration of the visit.
- 4. Qualified students nominated by the school will be accepted by the college for advanced study. Per year the number of such students will be determined with bilateral discussion.
- 5. The institutions have to provide the list of students in advance before sending the students for laboratory work/ Library visit/ research projects etc.
- 6. All travel and living expenses will be the responsibility of the sending institution or of the students personally.
- 7. Summer camp or summer school for students is encouraged on both sides. The travel and living expenses will be the same as item 6.

- Both institutions will encourage joint collaborations and will try jointly to apply for financial support for collaborative research projects from Governments as well as privet sources.
- 10. This Agreement constitutes the entire Agreement between the parties. There are no understandings, agreements or representations-oral or written-not specified herein regarding the Agreement. The Agreement will become effective immediately on the date of signing this document by the designated representative of both institutions and will remain in force for a period of five years. The Agreement may be amended or extended by mutual written consent of the two parties. Morigaon College and Morigaon Girls H.S.School, by the signatures of their authorized representatives below, acknowledge having read and understood the Agreement and agree to be bound by its terms and conditions.
