The general objective of this **Memorandum of Understanding** is to stimulate and facilitate the development of collaborative and mutually beneficial programs which serve to enrich students, faculty members as well as local youths of both the institutions and promote cordial relationship between the two institutes.

Thus, **Morigaon College** and **Rana Club, Morigaon** have agreed that in support of their mutual interests in the field of education and sports, both the institutes will jointly carry out some activities like training programmes, organization of orientations, fitness camps and other youth development programmes from time to time.

The two educational institutes will:

- a) Cooperate in the exchange of information relating to their activities in sports and youth development in the fields of mutual interests.
- b) Regular practice and promotion of football in the district level.
- d) Regular practice and promotion of cricket in the district level.
- e) Cultivating Sports Culture among the youths.

The aim of the Memorandum of Understanding is to achieve a broad balance in the respective contributions and benefits of the collaboration, and this shall be subject to periodic review by both institutions.

The collaborative activities as per this MoU shall be governed by the rules and regulations of both the institutions.

This agreement will be valid for a period of 5(five) years from the date of signature and may be extended by mutual written agreement.

Either institute may terminate the agreement at any time during the agreement period by the provision of three months written notice to the other institution.


