The general objective of this **Memorandum of Understanding** is to stimulate and facilitate the development of collaborative and mutually beneficial programs which serve to enrich students, faculty members as well as the local youths of both the institutions and promote cordial relationship between the two institutes.

Thus, **Morigaon College** and **Morigaon Town Club** have agreed that in support of their mutual interests in the field of education, training and orientation in sports, both the institutes will jointly carry out some activities like training programmes in sports, organization of orientations, and other development programmes related to youths from time to time.

**The two educational institutes will:**




